all that piece, parcel or lot of land in Travelers Rest, Bates Township, Greenville County, State of South Carolina: Beginning at an iron pin on corner of Guy McCarrell property and running thence N. 72 1/2 E. with said McCarrell line 200 feet to an iron pin; thence N. 31 1/2 W. 90 feet to an iron pin; thence S. 73 1/2 W. 100 feet to an iron pin; thence S. 17 1/2 E. 90 feet to the beginning corner, and containing approximately 4/10 acre, more or less.
