Terrell P. Watts, Sr. and Mable E. Watts, their heirs and assigns, forever:

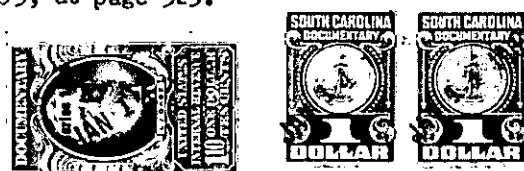

BEGINNING at an iron pin on the northern side of Manhattan Boulevard at the joint front corner of Lot Nos. 78 and 79 and running thence with the joint line of said lots N. 25-15 E. 240 feet to an iron pin; thence along the joint rear line of Lot Nos. 79, 80, 87 and 88, N. 64-45 W. 200 feet; thence along the joint line of Lot Nos. 80 and 81, S. 25-15 W. 302.6 feet to an iron pin on the Northern side of Manhattan Boulevard; thence with said Boulevard along a curved line, the arcs of which are N. 88 E. 112.4 feet and S. 72-45 E. 80.8 feet to an iron pin; thence still along said Boulevard S. 64-45 E. 20 feet to the beginning corner.
