Keeves, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, known as Tract No. 6 of Plat of property of D. E. Tripp, recorded in the R. M. C. Office for Greenville County in Plat Book N at page 161, containing 14.57 acres, more or less and having the following metes and bounds, to-wit:
