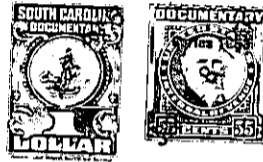
BEGINNING at an iron pin on the Northern side of North Monticello Road at the joint front corner of lot Nos. 74 and 75 and running thence with the joint line of said lots N. 19-40 E. 200 feet; thence N. 70-20 W. 83.23 feet; thence with the line of lot Nos. 73 and 74, S. 19-40 W. 200 feet to a point on the Northern side of North Monticello Road; thence with said road S. 70-20 E. 83.23 feet to the point of beginning.

The foregoing premises are conveyed subject to the following restrictions:

No residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than Forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

This conveyance is subject to all easements and rights of way of record.
