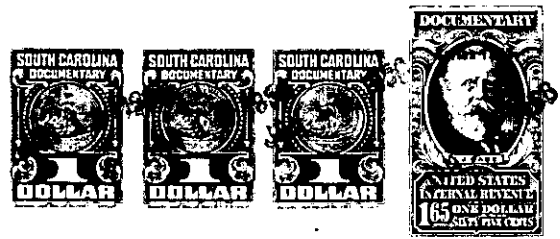
That I, H. R. Stephenson, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ray C. Ballew and Patricia H. Ballew, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the westerly side of Woodberry Way, near the City of Greenville, S. C., being shown as Lot No. 18 on the plat of Hollyvale as recorded in the RMC Office for Greenville County, S. C. in Plat Book "Y", page 131, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Woodberry Way at a point 201 feet south of the southwesterly corner of the intersection of Woodberry Way and Timber Lane, said point being the joint front corner of Lots Nos. 18 and 19, and running thence N 67-44 W 207.3 feet to an iron pin on a creek; thence along the creek as the line, a traverse line being S 44-07 W 116.6 feet to an iron pin, joint rear corner of Lots Nos. 17 and 18; thence along the joint line of said Lots S 70-51 E 255 feet to an iron pin on the westerly side of Woodberry Way; thence along the westerly side of Woodberry Way N 19-53 E 95 feet to the point of beginning.

As part of the consideration hereof this property is conveyed subject to the restrictive covenants applicable to Hollyvale as recorded in the RMC Office in Deed Book 440, page 537.
