to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said I. C. OWENS, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 1, North Acres, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "E5", pages 12-13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Cuttino Road, joint corner with property of F. S. Cuttino, and running thence along Cuttino Road N. 72-20 E. 120.6 feet to an iron pin; thence around the curve of Cuttino Road and Neal Circle, the chord of which is N. 48-25 E. 20.5 feet to an iron pin; thence along Neal Circle N. 10-50 W. 80 feet to an iron pin; thence N. 64-14 W. 80.6 feet to an iron pin in the line of the Cuttino Property; thence along the line of the Cuttino Property S. 25-10 W. 100 feet to an iron pin, the point of beginning.
