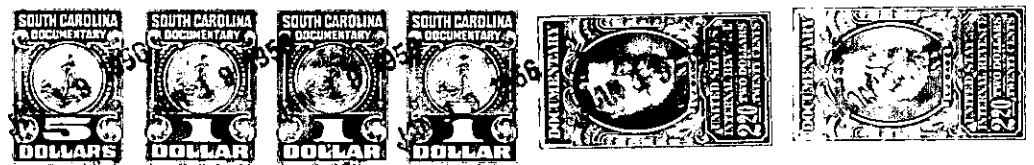

All that lot of land in Greenville County, State of South Carolina, on the southeastern side of Mt. Eustis Street, in the City of Greenville, being shown as Lot No. 20 on a Plat of F. P. Beattie Subdivision, recorded in Plat Book C at Page 236, and described as follows:

BEGINNING at a stake on the southeastern side of Mt.
