

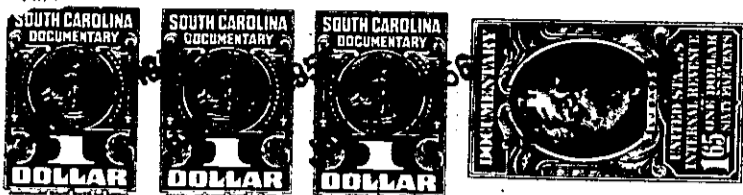

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
these presents do grant, bargain, sell and release unto the said Howard Thomason and Hazel  
Thomason, their heirs and assigns,

All my one-half (1/2) undivided right, title and interest in, of  
and to the following described property:

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, situated on a new road leading eastward from  
the St. Mark-Chick Springs Road, about One (1) mile northward from  
Chick Springs, being designated as Lot Number Twenty Nine (No. 29) of  
the W. B. Williams property, according to survey and plat thereof by  
H. L. Donahoo, Surveyor, dated January 21, 1947, recorded in the R.M.C.  
office for Greenville County, and having the following courses and dis-
