to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jack P. Davis and Sarah M. Davis,

All that certain piece, parcel or lot of land situate, lying and being near the city of Greenville, in Greenville County, state of South Carolina, being known and designated as Lot No. 14, Section 1, subdivision known as Lake Forest as shown on plat thereof recorded in the R. M. C. Office for Greenville County in plat book GG page 17, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northwesterly side of Lake Fairfield Drive, the joint front corner of Lots 13 and 14; and running thence N. 44-11 W. 281.1 feet to an iron pin joint rear corner of Lots 13 and 14; thence N. 80-21 E. 153.3 feet to an iron pin joint rear corner of Lots 14 and 15; thence with the joint line of said lots S. 36-46 E. 216.8 feet to an iron pin on Lake Fairfield Drive; thence along Lake Fairfield Drive S. 57-37 W. 100 feet to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

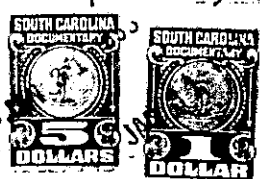
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.
