All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, Austin Township, near the town of Mauldin and being more fully described as follows:

BEGINNING at an iron pin (Leo Champion's corner), and running thence N. 74-35 E. 487.5 feet to pin; thence S. 30 E. 103.5 feet to an iron pin; thence S. 36-30 E. 83 feet to pin; thence S. 74-35 W. 515.5 feet to pin; thence N. 24-30 W. 130 feet to the beginning corner, containing two acres, more or less.
