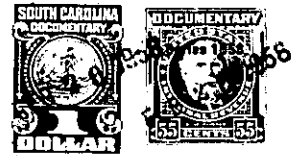
Know All Men by These Presents:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot 28 on plat of property of E. P. Kerns recorded in Plat Book "W" at Page 17 in the R. M. C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
