ALL that piece, parcel or lot of land near the City of Greenville, State of South Carolina, being known and designated as Lots No. 45 and 46 of a subdivision known as Bellwood Estates, as shown by a plat thereof, dated May, 1950, made by Dalton & Neves, Engineers, and having the following metes and bounds, to-wit:

BE GINNING at an iron pin joint corners of Lots No. 44 and 45 and running thence along the line of said Lot No. 44, N. 59-30 W. 150 feet to iron pin; thence running at an angle S. 53-20 W. 76 feet to iron pin; thence S. 30-30 W. 70 feet to iron pin at rear corner of Lot No. 47; thence running with the said Lot No. 47, S. 59-30 E. 179.5 feet to iron pin on Oxford Boulevard; thence with the said Oxford Boulevard N. 30-30 E. 140 feet to iron pin at point of beginning.

NO residence costing less than Five Thousand (\$5,000.00) Dollars, shall be erected on lots fronting on Old Rutherford Road or Oxford Boulevard; no residence costing less than Three Thousand Five Hundred (\$3,500) Dollars, shall be erected on any other lot in Bellwood Estates; no residence shall be erected on any lot nearer than twenty-five (25) feet to the front line; no outside toilets permitted.

THIS property sold subject to rights of way to Duke Power Company, granted or to be granted, for residence power lines.
