ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, known and designated as Lot No. 146 of the property of Cuttino Heirs as per plat made by W. A. Bunn, August, 1939, and being more particularly described as follows:

BEGINNING at a point on an unnamed street running East from McCarter's Shop Road, and a street parallel to and South from Lee Road, said point being joint corners of Lots No. 141 and 146 and running thence with the common line of said lots, N.14-45 E. 187.6 feet to a point on the rear line of Lot No. 208; thence along the rear line of Lots 208 to 202 inclusive, S.74-33 E. 201 feet to a point on the rear line of Lot No. 202; thence along the rear line of Lots 183 to 189 inclusive, S.14-45 W. 179.2 feet to a point on said unnamed street; thence along the Northern line of said unnamed street, N.76-12 W. 200 feet to the point of the beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and her Heirs and Assigns forever.

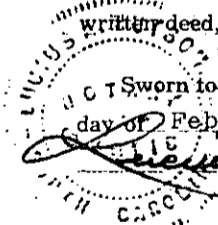
