Howard, deceased in consideration of the sum of One and No/100 in the State aforesaid, DOLLARS, and partition of real estate to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William G. Howard, his heirs and assigns,

ALL that certain piece, parcel or tract of land situate lying and being in the County of Greenville, State of South Carolina in Oneal Township containing 56 acres more or less, known and designated as Tract No. 4 of the property of W. G. Howard Estate according to a plat made by Terry T. Dill, October, 1955 and of record in the R. M. C. Office for Greenville County.

BEGINNING at a point in the Locust-Tigerville Highway at joint corner at Tract Nos. 4 and 6 and running thence with line of Tract No. 6 N. 21-15 W. 528 feet to an axle; thence N. 15-15 E. 963 feet to a poplar; thence N. 61-45 E. 234.2 feet to an iron pin; thence with line of Tract No. 5 N. 7 -30 W. 641 feet to an iron pin; thence with line of Tract No. 3 S. 82-46 W. 1568 feet to an iron pin in center of Bailey Road; thence with Bailey Road as follows: S. 14 W. 700 feet; S. 15-53 E. 372.7 feet; S. 29-33 E. 100 feet; S. 51 E. 450 feet; S. 68-36 E. 350 feet; S. 62-46 E. 200 feet; S. 55-28 E. 400 feet; S. 60 E. 232 feet to the beginning corner.

BEING a portion of the tract of land owned by W. G. Howard at the time of his death and this deed is made in accordance with the authority vested in me under the terms of the Will of the said W. G. Howard which is of record in the Probate Office, Greenville, S. C. in Apartment 417, File 20. By the acceptance of this deed the Grantee herein agrees to a partition and division at this time and in this manner of the real estate referred to in said Will rather than have all of said real estate conveyed to the grantee and the other devisees named in said Will, as tenants in common.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
