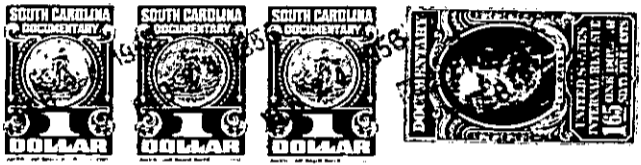

All that certain piece, parcel or lots of land in Greenville County, State of South Carolina, being known and designated as lot # 13 and the Northern one-half of lot # 15, Block B, as shown on a Plat of Pinehurst, recorded in the R.M.C. Office for Greenville County in Plat Book S at Page 7, and being more particularly described as follows:

BEGINNING at an iron pin on the Southwest side of Pinehurst Drive, at the joint front corner of lots 11 and 13, and running thence with the line of lot # 11, S. 62-23 W. 143.3 feet to an iron pin; thence S. 27-37 E. 90 feet to an iron pin in line of lot # 15; thence with a new line through the middle of lot # 15, N. 62-23 E. 142 feet, more or less, to an iron pin on Pinehurst Drive; thence with said Pinehurst Drive, N. 26-48 W. 90 feet to the point of beginning.
