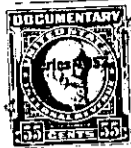

That I, W. B. REVIS, in the State aforesaid, in consideration of the sum of Three Thousand Five Hundred and no/100 (\$3,500.00)---DOLLARS.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged). have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The City of Greenville, S. C.:

ALL that certain piece, parcel or lot of land lying and being in Greenville County, South Carolina:

BEGINNING at a Persimmon tree on the South margin of the Saluda Road and running thence N 64 W, 693 feet to a stone; thence N 42 1/2 W, 526 feet to a stone near the head of a cove; thence S 73 1/2 W, 349 feet to a stone corner; thence S 10-3/4 W, 273 feet to a stone corner; thence N 69 1/2 W, 241 feet to a stone in M. R. Bell's line; thence with Bell's line as follows, N 5 E, 23 poles to a small Poplar; thence N 18 E, 32 poles to a spanish oak; thence N 62 E, 16 poles to a Hickory; thence S 77 1/2 E, 28 poles to Locust stump; thence S 84 E, 4 poles to a stake in Davis line; thence with Davis' line S 80 E with the Davis line 457 feet to a stake in Fall Creek in Davis' line; thence down and with the meandering of the creek and with the Davis line 844 feet to a stake at the mouth of the Davis spring branch; thence up said branch 466 feet to the mouth of a culvert in and across Saluda Road; thence with said road S 5 1/2 W, 291 feet to a stake in the road; thence with the road S 25 1/2 W, 315 feet to the beginning corner and containing 15 acres, more or less, being lands of the J. C. Revis, Estate.

Being the same conveyed to me by Alta Revis and J. C. Revis by deed dated August 21, 1933, recorded in the R. M. C. Office for Greenville, South Carolina in Deeds Book 191, Page 276.

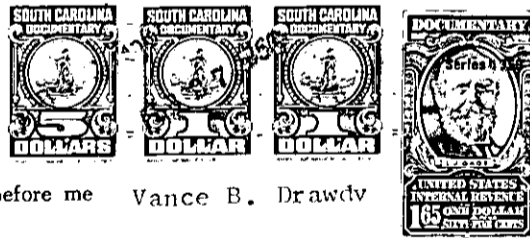
