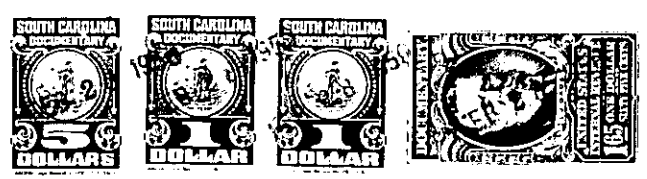
All that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, being known and designated as Lot No. 26 on Plat of Lake Forest Heights made by Piedmont Engineering Service, November 1955, and recorded in the R.M.C. Office for Greenville County in Plat Book 66, at page 153, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Scotland Circle, at the joint front corner of Lots Nos. 26 and 25, and running thence with the line of Lot No. 25, N. 28-13 W. 213 feet to an iron pin; thence N. 37-38 E. 113.7 feet to an iron pin, corner of Lot No. 28; thence with the line of Lot No. 28, S. 49-40 E. 110 feet to an iron pin, rear corner of Lot No. 27; thence with the line of Lot No. 27, S. 12-09 E. 180 feet to an iron pin on Scotland Circle; thence with the Northern side of Scotland Circle, S. 71-37 W. 95 feet to the point of beginning.
