Lindsey, her heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, designated as Lot # 3 on a Plat of Property of John G. Wilson, the same being recorded in the R. M. C. Office for Greenville County in Plat Book "W" at page 163, and having according thereto the following metes and bounds, to-wit:
