Know All Men by These Presents:

That I, WALTER W. GOLDSMITH in the State aforesaid, in consideration of the sum of Five Hundred Ninety-five & 00/100-----(\$595.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. J. DOUGLASS and D. H. DOUGLASS, JR., their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as Lot No. 18 of a subdivision known as Section "C", of Englewood Estates, as shown by a Plat thereof, dated December, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "B", at Page 13.

BEGINNING at an iron pin on Cherokee Drive at joint front corners of Lots No. 17 and 18 and running thence along the line of said Lot No. 17, N. 87-30 W. 175 feet to iron pin in line of Lot No. 16; thence running with the line of said Lot No. 16, S. 2-30 W. 72 feet to iron pin on Cheyenne Drive; thence running with the said Cheyenne Drive, S. 87-30 E. 150 feet to iron pin at curve; thence in a curve in a northeasterly direction 34.6 feet to iron pin on Cherokee Drive; thence running with the said Cherokee Drive, N. 2-30 E. 47 feet to iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than Five Thousand (\$5,000.00) Dollars.
2. No house is to be built closer than fifty (50) feet to the street.
3. No temporary house is to be erected on said lot.

THIS deed is subject to any rights-of-way now existing.

GRANTEE to pay taxes for the year 1956.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
