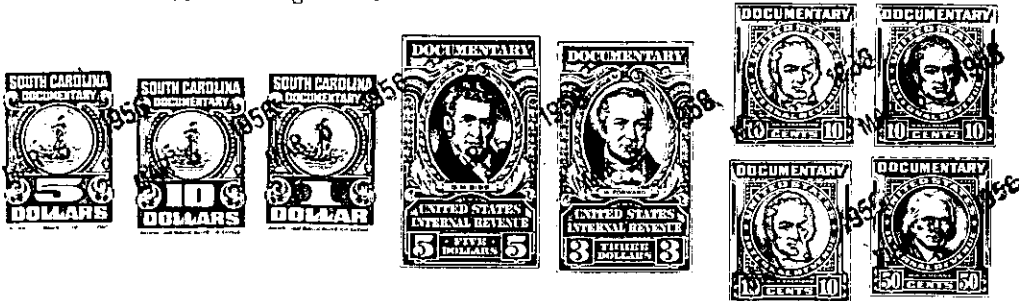
That Emma L. Flinkingshelt in consideration of the sum of Exchange of property valued at \$8000.00 DOLLARS
