That I, MRS. IVA HOLCOMBE in consideration of the sum of Two Hundred Thirty and No/100----- in the State aforesaid, DOLLARS,

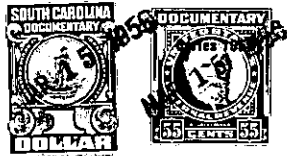
