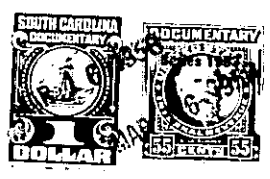
That We, FORD MCKINNEY and KATHERINE H. MCKINNEY,
