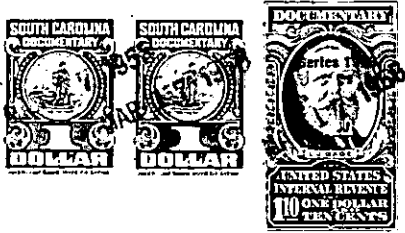
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said GLYNN A. LINDSEY, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, at the Southeast corner of the intersection of Zara Street and Maco Street, being known and designated as Lot No. 1 of the property of the Central Realty Corp., as shown on plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book B, at page 105, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast corner of the intersection of Zara Street and Maco Street, N. 64-30 E. 143.3 feet to a stake at the corner of Lot No. 4; thence S. 25-30 E. 50 feet to a stake at the corner of Lot No. 2; thence along the line of Lot No. 2, S. 64-20 W. 133.3 feet to the corner of Lot No. 2, on the East side of Maco Street; thence along the line of Maco Street, N. 36-10 W. 51.2 feet to the beginning corner.
