in consideration of the sum of Two Hundred Forty-four and No/100- in the State aforesaid, DOLLARS,

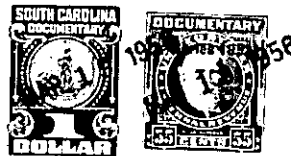
