Orr,

All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as lot No. 25, Block C, on plat of Brookforest recorded in plat book BB page 41 of the R. M. C. Office for Greenville County, S. C., and having according to a recent survey made by R. W. Dalton, March 1956, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the northeastern side of Woodmont Circle, the front joint corner of Lots Nos. 25 and 26; thence with the joint line of said lots N. 55-42 E. 175 feet to an iron pin, corner of lot No. 7; thence with the line of said lot N. 34-18 W. 70 feet to an iron pin corner of Lot No. 24; thence with the line of said lot S. 55-42 W. 175 feet to an iron pin on the northeastern side of Woodmont Circle; thence with the northeastern side of said Woodmont Circle S. 34-18 E. 70 feet to the beginning corner.
