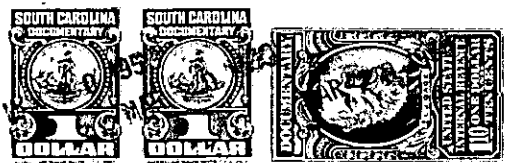
in consideration of the sum of Seven Hundred Fifty Five and 70/100 - - - - - DOLLARS,
