in consideration of the sum of Three Hundred Forty Three and 50/100 - - - - - DOLLARS,

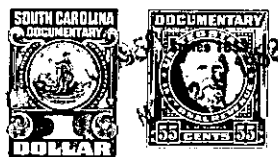
