in consideration of the sum of Four hundred One and 50/100 (\$401.50) - - - - - in the State aforesaid, DOLLARS,

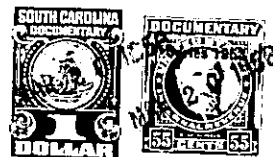
