to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

E. MITCHELL ARNOLD and MILLS H. HUGHEY, their heirs and assigns forever,

ALL that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, located on East Circle Avenue and being known and designated as a part of Lot No. 22 and a part of Lot No. 23 as shown on a plat of Eastlake Subdivision made by Dalton & Neves, June 1928 and recorded in the RMC Office for Greenville County in Plat Book "G", at page 229 and having according to said plat the following metes and bounds:
