That John C. Amick, Jr. in the State aforesaid, in consideration of the sum of One Thousand One Hundred Eighty Six and No/100 DOLLARS,

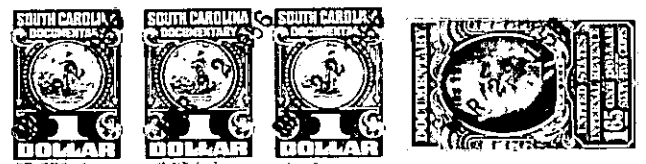
