in consideration of the sum of One Thousand Nine Hundred and No/100 - - - - - DOLLARS,

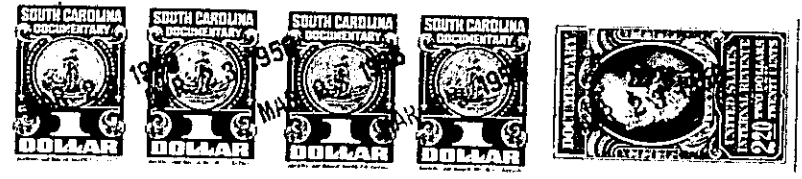
