in consideration of the sum of ONE HUNDRED TWENTY-TWO AND NO/100-----(\$122.00) DOLLARS,

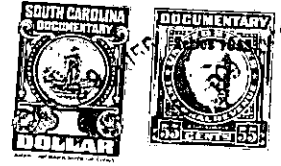
