to the granter(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

All that piece, parcel or lot of land with all buildings and improvements thereon situate, lying and being in Saluda Township, Greenville County, State of South Carolina, located about $1\frac{1}{2}$ miles South from the North Carolina-South Carolina boundary line near U. S. Highway 25, being a portion of the "Chestnut Springs" property having the following description:

BEGINMING on an iron pin on the edge of a proposed driveway, the Southeast corner of the lot, and runs thence in a Northwesterly direction in a straight line 192 feet, more or less, to an iron pin by a poplar on Joe Edwards' line; thence with the Edwards' line about S. 63-30 W. 25 feet to an iron pin, corner of Edwards; thence with Edwards' line about N. 30-30 W. 105 feet, more or less, to the center of a branch (stake on East bank thereof); thence up and with the center of the said branch as the line about 125 feet, more or less to a point (iron pin on bank of a branch by a walnut); thence a straight line in a Southeasterly direction 75 feet, more or less, to the beginning corner, containing .50 of an acre more or less.

Grantors also convey herein all rights of ingress and egress over lands of R. R. Scales, Jr., et al, as stated in deed recorded in Deed Book 520, page 249, referred to below.
