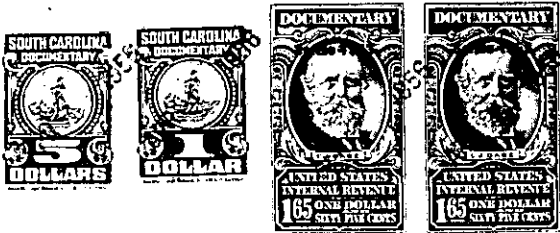

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville on the eastern side of Yancey Drive in Butler Township, being shown and designated as Lot 16 on plat of Lake Forest Heights recorded in Plat Book "GG" at Page 153, and having the following metes and bounds, to-wit:
