

ELEVENTH: To take possession, and order the removal and shipment of any of my property from any post, warehouse, depot, dock or other place of storage or safe keeping, governmental or private; and to execute and deliver any release, voucher, receipt, shipping ticket, certificate or other instrument necessary or convenient for such purposes.

TWELFTH: To make do and transact all and every kind of business of what nature or kind soever, including forms, applications, notes, deeds of trust, mortgages, and such other instruments in writing of whatsoever kind and nature as may be necessary, convenient or proper in the securing of Home Loan Guaranties and other veterans benefits through the Veterans Administration.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter and thing whatsoever in and about my estate, property and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present; the above specially enumerated powers being in aid and exemplification of the full, complete and general power herein granted and not in limitation or definition thereof; and hereby ratifying all that my said attorney shall lawfully do or cause to be done by virtue of these presents.

AND I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding on myself, my heirs, legal and personal representatives and assigns, whether the same shall have been done before or after my death, or other revocation of this instrument, shall have been reported or listed either officially or otherwise, as "missing in action", as that phrase is used in military parlance, it being the intent hereof that such status designation shall not bar my attorney from fully and completely exercising and continuing to exercise any and all powers and rights herein granted, and that such report of "missing in action" shall neither constitute nor be interpreted as constituting notice of my death, nor operate to revoke this instrument.

In the event of the death, incapacity or resignation of my attorney heretofore appointed, I do hereby appoint as a substitute None whose address is \_\_\_\_\_ my true and lawful attorney, in his place and stead, with the same powers as hereinbefore set forth.

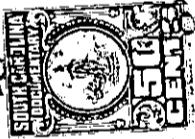
