That I, M. G. Proffitt in consideration of the sum of Fifty-five Hundred (\$5500.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John M. Jones,

All that piece, parcel or lot of land in Chick Springs Township, county of Greenville, state of South Carolina, on the southeastern side of U. S. Super Highway No. 29, being known and designated as the eastern portion of lot No. 2, all of lot No. 3, and the eastern portion of lot No. 4, on plat of property of Talmer Cordell recorded in plat book AA page 33 of the R. M. C. Office for Greenville County, and when described as a whole, has the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southeast side of Super Highway U. S. No. 29, in the front line of lot No. 2, which pin is 20 feet southwest from the front joint corner of Lots Nos. 2 and 3; thence through lot No. 2, S. 47-0 E. 280 feet to an iron pin on the northwest side of Pitts Street, which pin is 20 feet southwest from the rear joint corner of Lots Nos. 2 & 3; thence with the northwest side of said Pitts Street, N. 43-0 E. 155 feet to an iron pin in the rear line of Lot No. 4, which pin is 55 feet southwest from the rear joint corner of lots Nos. 4 and 5; thence through lot No. 4, N. 47-0 W. 280 feet to an iron pin on the southeast side of U. S. Super Highway No. 29, which pin is 55 feet southwest from the front joint corner of lots Nos. 4 and 5; thence with the southeast side of said U. S. Super Highway No. 29, S. 43-0 W. 155 feet to the beginning corner.

This is a portion of the property conveyed to the grantor by J. W. Hudgens and Fannie G. Hudgens by deed dated August 8, 1955 recorded in volume 531 page 342.
