in consideration of the sum of One Hundred Twenty-two and No/100----(\$122.00) DOLLARS,

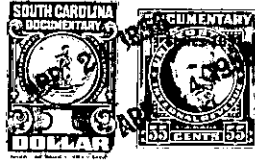
