ALL that lot of land, situate on the South side of West Belvedere Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 181 on Plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, S. C. in Plat Book "GG", page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of West Belvedere Road at joint front corner of Lots 180 and 181 and running thence with the line of Lot 180, S. 8-29 W. 142.3 feet to an iron pin; thence S. 78-04 E. 27.4 feet to an iron pin; thence S. 82-45 E. 56.7 feet to an iron pin; thence with the line of Lot 182, N. 8-29 E. 142.8 feet to an iron pin on the South side of West Belvedere Road; thence with the South side of West Belvedere Road, N. 81-31 W. 84 feet to the beginning corner.

ALSO all that lot of land, situate on the North side of West Belvedere Road and on the West side of Pinefield Drive, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 152 on Plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, S. C., in Plat Book "GG", page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of West Belvedere Road at joint front corner of Lots 152 and 153 and running thence with the line of Lot 153, N. 3-37 E. 132.6 feet to an iron pin; thence S. 85-26 E. 65.9 feet to an iron pin on the West side of Pinefield Drive; thence with Pinefield Drive, S. 12-09 E. 110 feet to an iron pin; thence with the curve of Pinefield Drive and West Belvedere Road (the chord being S. 43-10 W. 41.1 feet) to an iron pin on the North side of West Belvedere Road; thence with the North side of West Belvedere Road, N. 81-31 W. 70 feet to the beginning corner.

This property is conveyed subject to the restrictions applicable to South Forest Estates, which are recorded in the RMC Office for Greenville County, S. C. in Deed Book 547, at Page 66.
