in the State aforesaid, in consideration of the sum of \$1.00 and exchange of property valued at \$50.00.

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ervin Dorn, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 1 of a Sub Division of the property of W.R. Lewis and Essie L. Lewis as shown on revised plat thereof made by J. Mac Richardson, Surveyor, on April 12, 1956, which plat is a revision of, and addition to, the Lewis property made by J. Mac Richardson in March of 1954, and is a portion of Lots Nos. 149 and 150 of a Sub Division known as Camilla Park, as shown on Plat 4 thereof recorded in the R. M. C. Office for Greenville County, in Plat Book M at page 117, and having, according to said revised plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Yown Road at the front corner of Lot No. 1 of the revised plat made by J. Mac Richardson on April 12, 1956 and the corner of J. L. Masters property, and running thence with said Yown Road N 22-13 W. 91 feet to an iron pin at the corner of Lot No. 2 of said revised plat; thence along the line of Lot No. 2, S. 66-37 W. 161.1 feet to an iron pin at the rear corner of said lot, in line of Lot #4, thence S 45-07 E 65.6 feet to an iron pin at the rear corner of Lots Nos. 4, 5 and 1 of the revised plat of the Lewis property; thence along the line of the property of J. L. Masters, N. 77-15 E. 148.4 feet to the beginning corner.

The above described lot includes most of the lot conveyed to me as Lot No. 1 by W. R. Lewis and Essie L. Lewis by deed dated March 22, 1954 as recorded in the R. M. C. Office for Greenville County in Deed Book 496 at page 327, and it also includes a portion of Lot No. 2 and a portion of Lot No. 4 of the original plat made by J. Mac Richardson, from which the original description was taken, and this deed is made in order to correct the original deed and to make the property conveyed thereby conform to the revised plat which is to be recorded in the R. M. C. Office for Greenville County, and in exchange for the additional frontage and additional depth to said Lot No. 1, I have conveyed a small portion of the original Lot No. 1 which is now included in Lot No. 2 of the revised plat.
