in consideration of the sum of Five Hundred Forty-eight and 90/100----- DOLLARS,

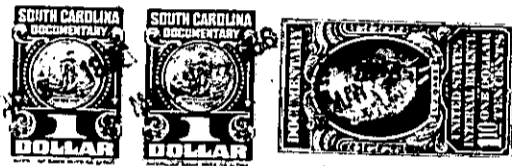
