Know All Men by These Presents:

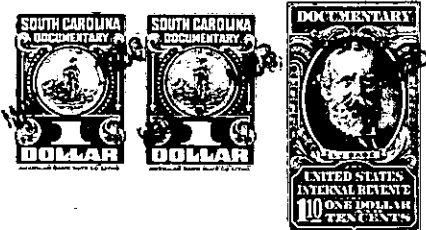
That I, B. E. Huff in the State aforesaid, in consideration of the sum of Eight Hundred and Fifty (\$850.00) - - - - - DOLLARS,
