ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 29 as shown on Plat of Pine Brook Extension made by W. N. Willis, Engineer, on June 1953, recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 73, and having, according to said plat, the following metes and bounds, to-wit:
