All that lot of land in the County of Greenville, State of South Carolina containing 0.33 acres, more or less, according to plat of property of Rosa M. Henderson et al made by R. K. Campbell dated May 4, 1956 according to plat of record in the R.M.C. Office for Greenville County in Plat Book JJ at Page 171 and having, according to said plat, the following metes and bounds, to-wit:

The point of beginning is situate approximately 210 feet east of the corner of property of Rosa M. Henderson and Gower.
