Know All Men by These Presents:

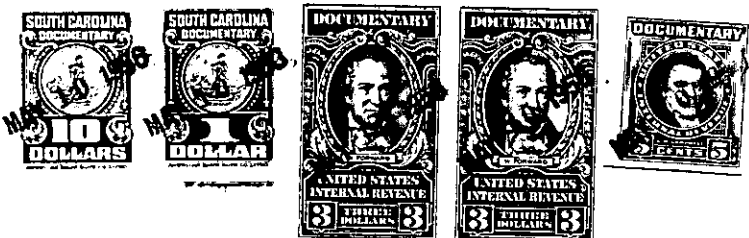

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jessie S. Baker, her heirs and assigns, forever:

all that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, Bates Township, town of Marietta, on the South side of State road no. 186, being shown as Lot no. one (1) on a plat of survey made by Dean C. Edens, L.S., April 2, 1956, recorded in Plat Book FF, page 404, and having according to said plat, the following courses and distances, to-wit:

BEGINNING at a point on the Southwest corner of State road no. 186 and Pearl Ave. and running S 33 W 261 feet to an iron pin; thence S 44 W 90 feet to an iron pin; thence N 45 E 271 feet to an iron pin; thence N 49-45 E 144 feet to the beginning corner.
