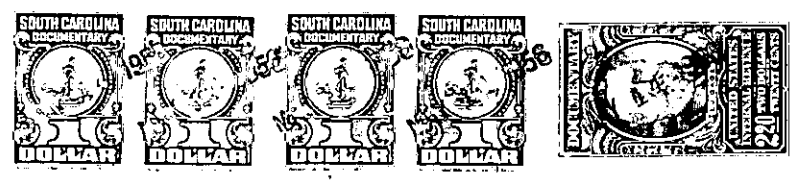

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, and being known and designated as Lot Number 59 of a subdivision known as McSwain Gardens, a plat of which is of record in the R.
