in consideration of the sum of Two Hundred Sixty Four and No/100-----DOLLARS,

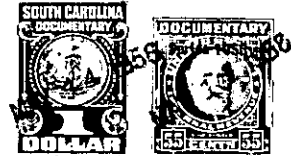
