BEGINNING J.M. Pace's and Mitchell Pace's corner and runs with his line N. 28 W. (3° vr) 375 ft. to stake in road; thence with road as follows; N. 67 E. 100° N. 47 1/2 E. 200 ft. N. 47 E. 195 ft. S. 68 E. 170 ft. N. 14 W. 132 ft. N. 38 E. 152 ft. N. 26 E. 100 ft. N. 38 E. 200 ft. N. 12 E. 288 ft. to stake in state line at fork of road; thence with state line N. 78 E. 130 ft. to stake; thence S. 30 1/2 E. 430 ft. to stake in fork of road; thence up and up and with old road as follows S. 16 1/2 E. 200 ft.
