Know All Men by These Presents:

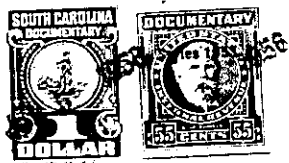
That I, OLA S. BENEYFIELD ( Mrs. James H. Beneyfield) in the State aforesaid,
