acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
the said Jessie E. Burns, her heirs and assigns, forever.

All that piece, parcel, or lot of land, situate and being in Bates
Township, Greenville, South Carolina, being known and designated as Lot No.
4 of the property of the James G. Lipscombe Estate and according to plat
made by Terry T. Dill, surveyor, and recorded in the R. M. C. Office for
Greenville County in Plat Book 11, at Page 87, and according to said plat,
having the following metes and bounds, to-wit:

BEGINNING at a point of the East side of street, said point being
310 feet North from Love Street and being the joint front corner of Lots
No. 3 and 4 and running thence with the line of said lot, N. 81-10 E. 159.3
feet; thence N. 2-00 E. 100.4 feet to joint rear corner of Lots No. 4 and 5;
thence with the line of said lot, S. 81-10 W. 162.5 feet to a point of the
East side of said street; thence with the East side of said street, S. 0-10
W. 100 feet to the point of beginning.
