


All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 4 and the major portion of Lot No. 5, Section "C" of Croftstone Acres, according to a plat thereof recorded in Plat Book "S", at pages 78 and 79, of the R.M.C.'s Office for said County, and having, according to said plat, the following metes and bounds, to-wit:
